IV. Oakland County Crisis Unit: Steve Norris

Mr. Norris provided an update on a novel medication, Opvee, utilized in Oakland County to address stimulant and opioid misuse leading to overdose. Over the last 45 days, they have administered 38 successful single doses, observing respiratory recovery within 30 seconds to 2 minutes, with full consciousness typically restored within 3 minutes. Law enforcement training involves implementing protocols, educational videos, and equipping officers with stopwatches to ensure a proper wait time of 2.5 minutes before considering a second dose. Follow-up crisis response checks are conducted for consumers who have received the medication and no negative side effects have

been reported. While similar to Naloxone, issues persist with Naloxone's over-administration due to inadequate training. Opvee's availability is limited as data is still being gathered in clinical trials, and funding primarily comes from grants rather than state allocations. Ms. Eckert reported that Region 10 has submitted the proposal to MDHHS for the Recovery Incentives Pilot Program. This program will start on October 01, 2024, for FY25. Region 10 received feedback from 5 providers (New Paths Inc., Great Lakes Recovery Mission, Arbor Recovery Michigan, Sacred Heart Rehabilitation Center, and Flint Odyssey House) stating that they would be interested in participating. Region 10 is waiting to hear from MDHHS for next steps. Ms. Eckert informed the board that this program is evidence based and will serve Medicaid participants that have an OUD or stimulant use disorder. A separate company will be contracted by MDHHS to oversee enrollment, screenings, and the incentives.
