6. <u>CEO UPDATE</u>

Mr. Johnson reported that there are no significant new updates at this time. Mr. Johnson indicated that the scheduled changes to the Open Meeting Act will not impact the SUD Oversight Policy Board.

Region 10 has applied for American Rescue Plan Act (ARPA) funds from MDHHS to employ more peer recovery supports connected to our Access Center in order to address significant numbers of eligible screeners not making it to their intake appointment. Region 10 has also applied for funds to engage and support Recovery Community Organizations in Region 10.

The Region 10 Board approved the purchase of a new building for Region 10. Region 10 currently shares space with St. Clair CMH. Due to staff growth with St. Clair CMH's CCBHC program, St. Clair CMH needs the space that Region 10 occupies.

7. <u>BUDGET</u>

A. PA2 (Liquor Tax) Funding Request – Genesee County (voting for Genesee Members only)

Ms. Eckert presented on the PA2 Funding Request for Genesee County. The PA2 Funding request is a continuation of the current Genesee Health System (GHS) initiative to reduce suicide through SUD treatment and prevention for Genesee County. Ms. Carrie Chanter gave a detailed presentation on the continuation of this important program to fund a 12-month media campaign in addition to a targeted suicide prevention training opportunity for professionals and community members in Genesee County.
