#### **5.** CEO UPDATE

Mr. Johnson presented the CEO Update and Agenda Item #6 Budget indicating a surplus in Medicaid funding. Mr. Johnson presented on the PIHP's Block Grant Funding.reductions, the potential use of State Opioid Response (SOR) funding. MDHHS is expected to receive an additional \$52 million in SAPT funds to use for through September 2022. Mr. Johnson will provide additional updates regarding the \$52 million in SAPT funding.

Mr. Johnson indicated that the Direct Care Wage Increase for appropriate SUD Providers has been approved by the PIHP Board through March 2021. The PIHP will seek approval from the Region 10 PIHP Board for continuation of the Direct Care Wage Increase for the remainder of FY21. Mr. Johnson opened the floor for discussion and questions.

## 7. PROVIDER NETWORK UPDATE

## A. St. Clair County DARE

Ms. Walsh presented on St. Clair County DARE and indicated that the law enforcement officers are discontinuing this program/PIHP agreement in St. Clair County schools. St. Clair County DARE is currently performing outreach and activities outside of PIHP funding.

# B. Genesee County Jail-Based MAT

Ms. Walsh presented on Genesee Count Jail-Based MAT. The PIHP has been approached by Genesee Health System and Wayne State University to discuss starting a Jail-Based MAT program in Genesee County. Funding for this program would utilize State Opioid Response Funding (not through the PIHP). Ms. Walsh opened the floor for discussion and questions.

#### C. Standardized Assessment - ASAM Continuum

Ms. Walsh presented on Standardized Assessment – ASAM Continuum MDHHS released the ASAM Continuum Tool to be utilized by SUD Treatment Providers instead of the GAIN Assessment Tool. Ms. Walsh indicated that Region 10 PIHP is in the preliminary planning stages with training / updates to the PIHP MIX System. It is expected that the ASAM Continuum Tool will be beneficial to the Provider Network and Enrollees due to the ease of use and completion time. Target implantation date is October 1, 2021. Ms. Walsh opened the floor for discussion and questions.

#### D. Port Huron OTP Developments

Mr. Briggs gave an update on the Port Huron OTP (Opioid Treatment Program) developments regarding the expansion of services to the Port Huron area. Meridian is in the process of looking at properties in the Port Huron area. Meridian will be hosting a town hall meeting on Medication Assisted Treatment (MAT) to educate the local community on the services being offered. Mr. Briggs opened the floor for discussion and questions.

# E. Opioid Health Home

Ms. Walsh presented on Opioid Health Home state-wide initiative and noted that Region 10 PIHP will be funding this program with the SOR grant. Additional updates will be forthcoming for this initiative. Ms. Walsh opened the floor for discussion and questions.
